Graulich Fire Convention Global inner rules

1. Responsibility of organizers and volunteers

Organizers and volunteers of the convention can't be taken for responsables of injuries or damages suffered or perpetrated by participants, unless they are founded in reason of a serious or deliberated act of negligence of the host or his representatives or assistants.

2. Responsibility of participants

Every participant of the convention, including artist or volunteer is responsible, for him, for minor people under his watch, and, as far as possible, competences and authority, for his surroundings :

- His health
- His safety
- The respect of site environment
- Equipments and belongings entrusted
- His behavior

Each participant committing himself to respect all the rules which be given to him, as well from the present internal rules, as in his participation :

- To the different workshops
- To the firespace
- To a volunteer action

3. General access conditions

• Inner rules

Every participant penetrating in the perimeter of the citadel must comply to the present inner rules.

• Animals

Our animals friends won't be admitted in the citadel or the campside spaces.

• Risks acceptance

Every person penetrating in the perimeter of the event accept to be confronted to an important crowd et to the use of ignited juggling equipment, and declares itself in mental and physical health compatible with the so-called risks.

• Graulich convention burner pass

It represents the permission to access to the workshops, stages, trainings et other activities offered during the convention.

The freedom of circulation in the perimeter of the site is under condition of visible and permanent pass holding, appropriated to the different places for participants, volunteers, artists and organizers. Only people having the appropriated pass, or accompanied, as an exception, by an organizer can

pretend to access to the different places of the site.

- **Forbidden access**

Organizers have all authority to forbid access to every people. This interdiction shall not be motivated.

4. Alcohol consumption

Alcohol introduction and consumption on the site may be allowed only for people over 18 years old, and only in so far as it doesn't generate any behavior that may affect the health and safety of property and persons or morals.

5. Safety

- **Relief to people and property**

Some staff dedicated to medical care and public order maintaining is present on site for ensure the participants safety. For evident reasons of efficiency and organizing, it is asked to contact this staff in priority before contacting external rescue.

This staff is invested of all authority to perform any first aid gestures, fire safety and peace maintaining all along the convention.

- **Workshops participation**

The good progress of workshops is the responsibility of their leaders, whom have all authority to define specific safety rules, including for participants choice, level of practice and equipment to use.

- **Firespace participation**

Firespace specific rules are displayed around the place. During the opening hours, it's constantly on the watch of several people, organizers and/or volunteers, who have instructions to ensure health and safety of the participants, as well as the good proceeding of the event. They have all authority to

- Authorize access of participants
- Authorize specific equipments use
- Limitating the number of people present on the firespace, regarding of the equipments used or the number of participants
- Stopping, temporarily or permanently the access of the firespace to all or part of participants.

- **Personal equipment**

Good state and safety of the used equipment his under the responsibility of the participants. Leaders of workshops and firespace may authorise or forbid their use, without any possibility of recourse. Organizers or volunteers shall not be convicted for loss, theft or deterioration of equipments.

- **Fire using**

Fire juggling is strictly restrained to the firespace and specific workshops, specifically authorized by a fire safety competent organizer.

Campfire or braziers is strictly forbidden in the campside perimeter.

The use of pyrotechnic devices, of all class, may only be authorized by a fire safety competent organizer, under reserve of complying to safety rules required by the so-called devices, without prejudice to the established rules of their using places.

- **Electric devices**

Every use of electrical network is forbidden for every person, except authorized staff, excluding the use of classical electric devices such as phone chargers, computers, etc.

Organizers may disconnect all or part of connected devices without having to motivate their action.

6. Environment

Organizers commit themselves in favor of a sustainable development, and continue a dynamic of ecologic citizenship actions, while preserving the historical heritage of the place.

Each organizer, artist, volunteer and participant must work in this state of mind by simple and concrete actions.

- **Waste disposal**

Every waste generated must be put in appropriated containers, respecting specific rules of waste disposal.

- **Dangerous wastes**

Dangerous waste disposal is strictly forbidden on the site. In case of leak, especially of combustible, it is necessary to warn organizers and help to place absorbant products.

7. Behavior, respect of organizers, volunteers and participants

- **Respect for ethics and moral**

It is asked to every people to prevent every aggressive or insulting behavior, of all behavior or dressing contrary to good morals apt to bother other participants.

- **Respect for places**

It is forbidden to affix inscriptions or posters on every furniture or building, excepted for specific places intended for this purpose, or agreement of organizers.

It is asked to every participant to respect the place.

- **Toilets**

Free toilets are available for all. They must be used in exclusivity and maintained in a correct property state.

8. Gymnasium use

- **Fire juggling equipment**

No fire is allowed in the gymnasium, fire equipments can however be used, provided that these are perfectly protected in a way to keep clean the dedicated space.

- **Rest in the gymnasium**

Except for force majeure cases, especially linked to meteorological conditions requiring campside evacuation, it is forbidden to sleep in the gymnasium.

9. Campsite use

Access to the campsite is dedicated to people with a pass.

Campsite users are asked to respect an acceptable sound level.

Trash bags are available, cleaning of the campsite is under everybody responsibility.

10. Non compliance

All of the organizers and people in charge of the order preserving has every authority for prohibit, temporarily or permanently, the access of every people in the site of the convention, without possible recourse.

Non compliance with safety instructions, inner rules, and generally common rules of living together can bring the organizers to take necessary measures.

Organizers have all authority to escort the participants outside of the site, without any compensation, refund or other recourse.

11. Underage

- **Underage under 15 years old**

Every underage under 15 years old not accompanied by an adult won't be allowed to penetrate inside the site of the event.

Every underage under 15 years old not accompanied by an adult shall introduce his accompanist on demand of every organizer, at every moment of the event.

The accompanist adult is responsible of the underage on his watch.

A document specifying the particular conditions of access must be signed by the underage and his accompanist.

- **Underage over 15 years old**

Every non accompanied underage over 15 years old must have knowledge and sign the registration form, and make it sign by his legal representative. Access will be allowed only by presentation of this registration form.

12. Images relative law

Every participant authorize freely of charge, without any limitation of duration or place, in accordance to the French law relative to images, AVP association to reproduce on her website and all other support (publicity, gala, publication) realized as part of the manifestation or activities for a non commercial exploitation of his image.

Participants give up any action against the association that would be initiated by his image exploitation in the so-called frame.
